So, how can I help you? 8 Bereki: Well, um, when I spoke with Anderson, he told me that 9 he was going to obviously -- uh, he was, at the time, 10 I believe, trying to find someone to hand it off to --11 Leeb: Mm-hmm. 12 -- so that something could be done about it. Bereki: 13 Leeb: Yes. 14 Bereki: Um, and, um, he never got back to me. 15 Leeb: Got it. 16 Bereki: So, I'm trying to find out if, A, he did something, 17 was able to find someone, if it did get handed off to, 18 who it got handed off to, or if, basically, you guys 19 have concluded that, um, you're not going to do 20 anything. 2.1 Leeb: Got it. 8		it.

11		Department of Justice?
12	Leeb:	California. We asked them to review it. We didn't
13		give it to them, we asked them to review it to see if
14		it was something that they would want to look into.
15	Bereki:	Okay. And so, they declined.
16	Leeb:	That's correct.
17	Bereki:	And so, um, have you, uh, done the same with the
18		um, within the Orange County District Attorney's
19		office?
20	Leeb:	Yes. They did not want to do anything with it as
21		well.
22	Bereki:	Okay. All right. So, then, you're going to or,
23		you have closed your the investigation?
24	Leeb:	Yeah. The investigation is closed from our office.
25	Bereki:	Okay. And Mike, um, just so I can write it down

14		do anything about that issue as well.

18		like that filed?
19	Leeb:	Uh, yeah. There's been a number of reports written,
20		uh, regarding your case, sir.
